### Middle Class Tax Cut

We know that when Canadians have more money in their pockets, we build stronger communities, create more jobs, and continue to grow a stronger economy. As the very first order of business, our government took steps to lower taxes for middle class Canadians

and people working to join the middle class. This could save a single person almost \$300 a year, provide a couple or a family close to \$600 a year in savings, and nearly 1.1 million more Canadians would no longer pay federal income tax at all.



### **Investing in Your Family**

### The bigger, better Canada Child Benefit.

The Canada Child Benefit is giving your family more money- up to \$6500 per year, per child.

The average family has now received \$4,600 more under CCB than the previous Conservative plan.

The **CCB** is tax free. Just file your taxes to qualify.



### **Seniors**

Seniors can now receive up to **\$1,700** more per year.

The government increased Old Age Security and the Guaranteed Income Supplement to help seniors with the rising cost of living.

### **Single Canadians**

The average single Canadian is now saving \$330 a year through the Middle Tax Cut.

The government has cut taxes for 9 million middle class Canadians, by raising them on the wealthiest 1%.

### **Environment**

An average Ontario family of four will receive a \$307 Climate **Action Incentive payment** through their Income Tax return this year.

Climate change is a real threat. We are taking Action. We are putting a price on carbon pollution to encourage everyone to pollute less and make cleaner choices.

We are also keeping life affordable for families. The money collected by the federal government in Ontario is being returned to **Ontarians through the Climate** Action Incentive.

Climate Action Incentive payments will be delivered annually to Ontario families when they file their tax returns.

### **National Housing Strategy**

Affordable housing is more than just bricks and mortar. It's about improving the lives of families by relieving the burden of high housing costs, so that they have more money left over every month for groceries, transportation, warm clothing, and the unexpected costs of living.

Our goal is to help people of all ages and backgrounds, from new parents needing a second bedroom for their baby to lowincome seniors seeking an affordable home to retire in. The National Housing Strategy is an ambitious \$40 billion plan over a 10 year period. It will help to remove 530,000 families from housing need, create

100,000 new housing units and repair and renew more than

300,000 housing units, and cut chronic homelessness in half.


